Monthly, Maintenance yearly salary from \$57102 to \$58244.; EMT \$70 per trip; 1st responder, \$60 per trip, EVOC \$ 50 per trip, AMB Salary \$50 monthly. Motion carried. A list of Firemen and Ambulance crew placed with minutes.
