Board tabled appointment for Trustee (2year term). Summer Program insurance, tabled, as waiting for amounts of children to play on Summer Program. Drinking water report, tabled. Motion Shrader, second Carda to renew MB license for Beseda Hall. Inc. Motion carried.

MAINTENACCE: Rich stated last snow cleanup went well. Replaced lights in Nutrition center/ kitchen with LED and will work on Library. Old Sewer lift station was removed. SPN reviewing 25 punch list to be completed by Slowey. Clean up week scheduled for April 24-26. Cimpl Park (300 club signs) are repaired, and reviewing Billboard signs from 2017 in need of replacing, as Rich will contact Business owners, for updating. Board checked with Kulish on removing city dump, burn pile and trees on N Lidice, tabled.

FINANCIAL: Board stated to send Ordinance 8-711 (pet licensing) notices to residents not in compliance. 10 late water notices sent 3-20 and 3/ 2nd notices due 4-3 by 10 a.m. All paid.
